Foursome passes may be used as three separate guest passes and members must play with the guest. Free 2022 Foursome Passes and Guest Passes will be honored until the end of the 2022 season.

In exchange for permission to use a golf cart of the Westlake Master Association, Inc. (Westlake), the Member acknowledges that he/she has a valid driver's license and is familiar with the use and operation of the golf cart, and the Member covenants that he/she will use and operate the cart in a safe, prudent manner for the playing of golf. The Member agrees to return the cart in the same condition as he/she received it and shall be responsible for any damage or breakage. The Member also agrees that no right of action shall accrue to themselves for any loss or damage to person or property arising from the use of the cart or resulting from any mechanical failure or component of said cart. The Member further agrees to hold Westlake Golf and Country Club and/or the Westlake Master Association, Inc. (Westlake); and Linx Golf Management, Inc., (Linx) and/or Westlake Golf, LLC. , free and harmless against all claims arising from the operation of said cart. The Member shall assume the entire responsibility of loss or damage to cart, person, or property caused by a guest or passenger.

I/we currently own or are planning to purchase an electric golf cart. I/we understand that we must abide by Westlake's Title IV - Golf Course Rules and Regulations. Some of the guidelines are:

1. The golf cart must be maintained in a manner consistent with golf course standards.
 - a. Only electric carts designed to be golf carts are permitted
 - b. Registration sticker must be displayed on the golf cart body, above the driver's side front wheel.
 - c. Uniform reflective safety stickers or lights must be applied to all sides of the golf cart
 - d. Two amber reflectors must be placed on the front of the cart. Two amber reflectors must be placed on the sides of the cart. Two red reflectors must be placed on the rear of the cart
 - e. Any golf cart or golf cart-related items that are deemed inappropriate by the Golf Professional will not be allowed
2. The golf cart must be housed inside the owners' dwelling. Outside storage is not permitted.
3. A current copy of my insurance policy or proof of insurance stating that the golf cart is covered under the policy with a minimum limit of \$300,000.00 must be submitted to and held in the Community Association office. This policy should name the Westlake Master Association and the Management Company (Premier Management Associates) as certificate holders.
4. There will be no lending or sharing of golf carts. (Use is restricted to owners of the cart only.)

I (we) own an electric golf cart and have attached appropriate proof of insurance, showing that this vehicle is insured for use on the streets of the community and the golf course. I (we) have proper decals, reflectors, etc, as outlined in Westlake's Title IV - Golf Course Rules and Regulations. We have read and understood Westlake's Title IV - Golf Course Rules and Regulations about golf cart ownership and use.
